## **ABOUT THE EPOP SURVEY PROJECT**

The Entrepreneurship in the Population (EPOP) Survey Project is being conducted by researchers at NORC at the University of Chicago with funding from a grant from the Ewing Marion Kauffman Foundation. Questions about this research project should be directed to **EPOPresearch@norc.org**.

## **EPOP SURVEY PROJECT OVERVIEW**

The EPOP Survey has been conducted in 2022, 2023, 2024 and 2025; one more annual collections is planned. The survey is designed to understand the scope of entrepreneurial activities from adults 18 years and up in United States and result in a variety of measures of entrepreneurial behavior including current and former business ownership, whether individuals are currently taking or previously took steps towards starting a business, the extent to which individuals engage in freelance work, and engagement with the "gig economy." In addition to capturing the characteristic profile of the individuals involved in these various entrepreneurial activities across the U.S., the survey collects information on the behaviors, challenges, and resources available to individuals during the entrepreneurial process.

#### WHAT IS THE EPOP SURVEY CROSSWALK?

The EPOP Survey Item Crosswalk is a guide for navigating and exploring the EPOP Survey items. The Crosswalk transforms the 2025 version of the survey instrument into a user-friendly roadmap that takes you to where you want to go, without having to follow all of the complicated programming language shown in the questionnaire document. The Crosswalk includes all of the EPOP:2025 Survey items and highlights which ones are new relative to EPOP:2024. In the EPOP Survey, each respondent is logically assigned to one entrepreneurship group based on the entrepreneurial activity reported in the initial screening items. The seven (7) different groups are:

- 1. Current Business Owner
- 2. Current Freelancer
- 3. Nascent Entrepreneur
- 4. Former Business Owner
- 5. Former Freelancer
- 6. Withdrawn Entrepreneur
- 7. Non-Entrepreneur

The EPOP Survey Item Crosswalk isolates the various follow-up or ancillary survey items asked of each assigned entrepreneurship group to help you visualize the survey pathway using a Color Schema and Number Key shown in the legend. The legend also shows the standard text fills used for the specific entrepreneurship groups in the follow-up survey items. It is worth noting the gig work questions may be asked of any individual regardless of assigned entrepreneurship group and those survey items are specifically flagged, too. In EPOP:2025, there is also a set of items asked of microbusiness owners developed and funded by the Association for Enterprise Opportunity and those items are shown as new and are identified separately in the Survey Items list. All survey items are shown two ways in worksheet tabs:

"E" (Entrepreneurship) Group Paths - shows the survey pathway across the seven entrepreneurship groups, and Survey Items - shows the pathway through all EPOP Survey items with the full question text and flags which entrepreneurship groups were asked the item.

Ideally, this color-coded Crosswalk will facilitate understanding of the EPOP Survey, regardless of your background in questionnaire design.
